We speak truthfully and listen well; at the same time, we understand that if each individual is party to a decision, then that decision merits group support;






we also believe that proper communication is essential for collective safety, sound relationships, and higher productivity.

The JorAMCo Academy provides approved training to the standards of IR Part 66 at its facility in the Hashemite Kingdom of Jordan in association with Air Service Training AST (Engineering) of Perth, Scotland. AST will offer the approved Sandwich Course in Jordan; the courses meet the knowledge and skills requirements of IR Part 66, licensing categories B1.1 & B2 (which is equivalent to the Higher National Diploma HND, also the candidates have the option to pursue the BSc Degree at Perth, Scotland).

The Academy is further accredited by the United Kingdom Civil Aviation Authority (UKCAA) in association with AST as per the EASA 147 regulations, as well as the Jordan Civil Aviation Regulatory Commission (JCARC).

TRAINING

The Academy provides a fully – approved basic 'Sandwich Course' with approved examinations to meet the requirements of the IR Part 66 license in categories B1.1 and B2.

The Academy is the only non – EU Part 147 Approved Training School to provide this unique 'Sandwich Course' for Part 66 Category B licences, which combines the knowledge and experience requirements over a four - vear period.

This course is fully – approved by the United Kingdom Civil Aviation Authority (UKCAA), and can be offered to meet the requirements of IR Part 66 Licensing in Categories B1.1 and B2.

Each year of the course offers theoretical and practical training, On the Job Training (OJT) and a period of work experience, so that at the end of the program, candidates have the opportunity to apply for license issue if all requirements are met.





The following offers a brief overview of the course profile:

Years 1, 2 & 3 cover:

- 22 weeks of theoretical and practical training at the academy
- 3 weeks of OJT
- 23 weeks work experience, usually at 34 JorAMCo's hangars and shops

- Jordanian Higher Secondary School Certificate (Tawjihi) or equivalent.
- A medical certificate.
- Security clearances from applicable governmental departments.

As the primary language of instruction is English, applicants whose native language is not English, will have to sit for an English language competency test and go through 4-6 months of intensive Technical Aviation English course.
